SELECTION PROCEDURE AND FINANCIAL ARRANGEMENTS

I acknowledge that according to the procedure described below, CISV participants are selected, and I accepted the decisions regarding this selection taken by CISV Luxembourg.

SELECTION PROCEDURE

CISV Luxembourg is granted a limited number of attendants in International Programmes by the CISV International Office each year. This number depends on the number of delegations and participants we hosted in the previous years in international programmes organized by CISV Luxembourg. As we are a volunteer organization, the good cooperation of our members is extremely important. Unfortunately, we don't always get invitations for all ages.

The Board of CISV Luxembourg reserves the right to allow or deny a participant for an activity. This decision is taken based on the criteria described by CISV International (info file R-5 and R-6 (9008)). These documents are available on the website of CISV (www.cisv.org). Thereafter we apply the following selection criteria: Motivation, Presence at the CISV Weekends, Age, Maturity and Involvement in CISV (from parents as well)

If the number of candidates for a certain group (gender/age) is larger than the number of places, you will be informed in time how we will apply the selection procedure.

FINANCE
